President Bill Scoltock opened the meeting stating that the USPS Staff Council does not support or recommend anyone joining a union.

Treasurer's Report: Bill Scoltock

- Balance in checking is \$ 4,324.75 and savings \$ 53.02.

Human Resources Update: Mark Roberts, HR Director

- One-time payment of \$ 1,500 less taxes, 25% per IRS rules for bonus money, will be made on July 30, 2010, to eligible USPS staff employees.
- USPS staff employees will receive across the board a 1% salary increase to all eligible employees. Eligibility is posted at the HR website at <http://www.hr.ucf.edu/web/TJI/2009-2010SalaryIncrease.pdf> Retroactive pay goes back to 8/8/09. Paycheck dated 8/27/10 is the 1st check that recognizes higher salary, not the retro. Retro will be paid at a later date.
- Mark discussed the classifications issue. HR is waiting on PERC (Florida Public Employees Relations Commission) to make call on who is in unit and who is not and once sure will send out an announcement from HR.
- Whether you decide to join the union or not is your decision, you're still covered by contract. If you are promoted and don't want HR to take out union dues money, send an email to HR to stop taking it out.

- Health insurance premiums for Spouse Program change begins with premiums paid in July 2010; premium will be \$ 30 per couple.
